Membership Renewal

(due 1st April 2024)

Many thanks to those of you who have already renewed. It is quick and easy to renew on-line. Just go to the 'Membership' section of our website knutsfordu3a.co.uk and at the bottom of the page click on 'Beacon Membership Renewal' to go to the 'Renew On-line' page. Here you will find the Terms and Conditions of Membership followed by a final link to the Knutsford u3a Members Portal.

To log into the portal, you will need the e mail address and password you used when you registered for the Beacon Portal. If you need more help, there is a link you can click for more information towards the bottom of the 'Renew On-line' page.

PayPal

We encourage all who can to make their renewal payment through PayPal. Please take a look at the article on the next page where our webmaster, Tony Roberts, describes the benefits of PayPal.

Gift Aid

Last year we started claiming Gift Aid on members' subscriptions where they were eligible and this has enabled us to reduce the subscriptions this year.

- We can claim Gift Aid if you have paid the same amount or more in Income Tax and/or Capital Gains Tax in the tax year and you
- make a Gift Aid declaration that gives us permission to claim it.

The Gift Aid will be 25p for every £1 of your subscription so the tax we can claim on £12 will be £3.00. This will help us to keep subscriptions as low as possible. You can Gift Aid your subscription by ticking the Gift Aid box when you renew on-line or, if you renew by cheque, ticking the Gift Aid box on the paper form. We would be grateful if those of you who are taxpayers would consider ticking the Gift Aid box.

Please note that if each member at the same address is a taxpayer and wishes to Gift Aid their subscriptions you should NOT use the on-line facility to pay both subscriptions together. You can still renew online but each taxpayer should pay their own subscription and tick the Gift Aid box to allow us to claim Gift Aid. If you are unsure whether you will pay enough tax, please do NOT tick the Gift Aid box.

If you pay less Income Tax and/or Capital Gains Tax in a tax year than the amount of Gift Aid claimed on all your donations it is your responsibility to pay any difference.

Once you have renewed, please let us know if you:

- want to cancel your Gift Aid declaration.
- change your name or home address.
- no longer pay sufficient tax on your income and/or capital gains.

For those of you who cannot renew on-line there is a printable Membership Renewal form at the end of this edition of Kanuta or you can download the form from our website.

The Benefits of a Personal PayPal Account



Most of you will be aware of PayPal but are perhaps wary of using it. I have been using PayPal regularly for 21 years and I can thoroughly recommend it as a safe and convenient way of paying on-line. Renewing my u3a membership takes a few minutes and it saves our volunteers time and effort as well.

- PayPal is easy to use – it is a very straightforward way to send money to friends, family and businesses.
- There's no need to enter all your financial information every time you shop.
- PayPal uses details from your existing Credit / Debits cards but you only have to enter your name, address and card details once at the time you set-up your PayPal account. You can add or change cards at any time.
- PayPal encrypts your bank and credit card information, keeping that information safe.
- Using PayPal gives you an extra level of security and fraud prevention. If you pay for a purchase using PayPal that ends up being fraudulent, PayPal will help you get your money back.
- There are no hidden fees for using PayPal on-line.

As DC Andy Kevan, from the Cheshire Police Cybercrime Team, told us at our members' meeting last January, PayPal is one of the most secure on-line payment services. If you would like to set-up an account please click on the link below to start the process.

Leaving Knutsford at 9.30 am, we should arrive in Buxton by 10.30 am, when we have coffee and biscuits in the Pavilion Gardens restaurant (included in your price).

At 11am we will be met by guides, who will take those who wish to, for a guided walking tour of central Buxton, lasting a little over an hour. This walk costs £12 and needs to be booked on your order form please.

You are then free to find your own lunch in the cafés around Buxton or bring a picnic and sit in the delightful Pavilion Gardens. Plenty of seating available, and delicious ice cream!

At 2.30 pm, the performance of 'The Gondoliers' starts. This takes place in the beautiful Georgian Opera House designed by Frank Matcham, opened in 1903, and perfectly restored in 2001. The interior is a treat in itself! 'The Gondoliers' is part of the International Gilbert and Sullivan festival, performed by the world renowned National G and S Opera Company. I doubt if Gilbert and Sullivan need any introduction from me!

I would expect to be back in Knutsford by 6 pm.

On **Thursday 25th April** Adrian Long will describe how he climbed The Matterhorn with his son in September 1999 to celebrate his 50th birthday.

The Matterhorn 4,300m high (14,107 feet), ever since it was first climbed by Edward Wimpier in 1864, has been an objective for all mountaineers and a classic mountain peak known to everyone. For the ascent Adrian and his son traversed the mountain ascending the Italian ridge to the summit, and the Hörnli ridge in descent. A wonderful outing in perfect conditions with the Pennine Alps spread out below them. You will see some amazing photographs which cover the climb both in the ascent and descent including great images of the summit.
